



3- BRANCH OFFICE:


The Branch office of the trust can be opened in any part of the country for the smooth functioning of the trust. And/ or at such places as the Governing body of the trust may decide from time to time.



5- Financial Utilization of Trust





8.0 Meetings:

The meeting of the Board shall be convened by the chairman or in his absence by the vice chairman or on the request of 2/3rd majority of the whole members of the trustees.

The meeting shall be held at least once in every year. Seven days' notice shall be necessary for the meeting except in special cases. The notice shall be accompanying the agenda of the proposed meeting; all the decisions of the meeting shall be taken by 2/3rd majority of the whole members of trustees.

In the meeting, the chairman will have powers of casting vote. The quorum of the Board of trustees at a meeting shall comprise of 2/3rd of whole Trustee. In case on the appointed date, the quorum is not complete, the meeting shall be adjourned to another day and on the adjourned day the trustees present shall be the quorum. The meeting can be held anywhere in the world.

9.0 Board of Trustees:

9.1 The Board of trustees hereinafter called the Board shall comprise among the whole trustees

9.2 The member of the trust can be increased decided by the board of trustees from time to time by 3/4th majority of whole trustees. However, the maximum number of the trustee can be increased to 12 trustees.

9.3 In case of occurrence of any vacancy amongst the Trustees because of death, a new Trustee may be appointed to fill the Vacancy by first legal heir, successor or other Family member appointed by deceased Trustee respectively.

9.4 In case of occurrence of any vacancy amongst the Trustees because of resignation, incapacity or any other cause of any Trustee, a new Trustee may be appointed from the family member of the outgoing trustee.

9.5 The board of trustees shall have the following powers:

- i. To manage the properties, assets and funds of the Trust, from time to time, such regulations (not being inconsistent with this deed) as they may



- vi. To consider and finalize the annual report about the programs and activities presented by the honorary secretary and assess the overall trust performance



- xv. To receive the honorarium or salary against his/her services or involvement in any of the project or programs run by the trust, which must be decided by the board of trustees and approved by the chairman



10.2 Powers and Functions of the Chairman/ Vice Chairman:

The Chairman of the Board is the constitutional and administrative head of the trust and will remain the Chairman of the Trust for two years time and if due to death or any reason, vice chairman or decided by 2/3 majority by the whole trustees will become the acting chairman.

The Chairman shall be elected among the trustees by 2/3rd majority of the whole trustees, in case of difference, the Chairman shall be elected amongst the trustees by 2/3rd of the whole majority.

- i. Preside over all meetings of Board of trustees and the sub committees appointed by it.
- ii. Exercise general supervision over the functioning of the trust and general control and supervision of its properties.
- iii. Convene a special meeting of the Board, if and when necessary.
- iv. Perform such other functions as are entrusted by the Board.
- v. Will be competent to authorize any person to act for better performance and to achieve the object of the trust.

13.0 Banking

To open any type of bank account(s) whether saving account, current account, fixed or otherwise, in the name of the trust or institution(s) or programme(s) run by the trust with any bank(s) or post office(s) and to operate by the authorized signatory or signatories as board of trustees shall think fit and proper to authorize any person or persons by 2/3rd majority of the whole trustees, unless and until determined otherwise the such bank account(s) shall be opened and operated jointly with signatures of any three members of board of trustees.

14.0 General:

- a) The Trust may collaborate with other recognized and well established allied or akin to the objectives of the Trust.

- b) No office bearer has the power of sell, mortgage or in any other way transfer or dispose of any of the properties of the Trust, except as resolved by a resolution of the Board of Trustees, passed in a meeting specially convened for that purpose, with 2/3rd majority of the whole trustees.
- c) The Board of trustees may form rules for the conduct of administration and financial affairs of the Trust.
- d) The beneficiaries of the Trust shall be public in general without having regard to any caste, creed or community based on any religion.
- e) All receipts in trust will be the property of trust
- f) The activities of trust are capable of being extended/operated / conducted in whole of India and outside India.
- g) For any matter of urgent nature, a proposal may be circulated by the Chairman to the member of the trust and if appointed by the majority, it will be treated as passed in the meeting of the Board.
- h) The Trust may sue or be sued through the Chairman or Vice Chairman for and on behalf of the trust.

15.0 ACCOUNTS / AUDITOR:

- a) The Managing Committee shall keep proper books of account of the income and expenditure of the trust, which shall be closed every year on 31st March.
- b) Two external persons or one external auditing firm shall be appointed as Auditor/Auditors by the Governing Body of the Trust for the term of one year. The Auditor shall each year examine the annual financial records of the Trust and shall submit a written report to the Board of Trustees. The Board of Trustees shall present report to the Governing Body of the Trust at General Meeting for the purpose of information.

16.0 INVESTMENTS

The funds of the Trust shall be invested in accordance with the provisions of section 13(1) (d) read with section 11(5) of the Income Tax Act and the other provisions of the Income-tax Act in a manner that will ensure the exemption of

17.0 DISSOLUTION

- a) The dissolution of the Trust shall be approved by the Governing Body of the Trust.
- b) Upon the dissolution of the Trust, after the satisfaction of all of the Trust's incurred and accrued debts, liabilities and obligations, the balance of the assets of the Trust shall be distributed to such other institution or institutions having objectives similar to the objectives of the Trust, as determined in the sole discretion of the Governing Body of the Trust, provided that such distribution is consistent with distributions to organizations exempt from Income Tax under Section 11 of the I.T. Act 1961 or any successor Sections, and the regulations there under, provided, however, that no part of the distributions shall inure to the benefit of any private organization, shareholder or individual, and shall not be inconsistent with Paragraph 4(a) hereof


